The Waltham Forest (Prohibition of Stopping Outside Schools) Order 199

The Waltham Forest (Waiting and Loading Restriction)) Order 199 (Amendment No.

Notice is hereby given that the Council of the London Borough of Waltham Forest, hereinafter called the Council, propose to make the above-mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985 and the Road Traffic Act 1991.

2. The general effect of the Prohibition of Stopping Outside Schools Order would be, during the school term time, to impose no stopping restrictions Mondays to Fridays inclusive, on the schoolkeep-clear markings:

- (a) located as approximately indicated in Schedule 1 to this notice, between 8 a.m. and 4 p.m.
- (b) located as approximately indicated in Schedule 2 to this notice, between 8 a.m. and 9.30 a.m., and 3 p.m. and 4.30 p.m.

3. Exemption has been provided in the Order so that nothing in paragraph 2 above shall apply to school meal vehicles being used in certain circumstances

4. The general effect of the Waiting and Loading Order would be further to amend the Waltham Forest (Waiting and Loading Restriction) Order 1977, so that waiting and loading by vehicles would be prohibited;

- (1) (a) between 8 a.m. and 4 p.m. on Mondays to Fridays inclusive in the lengths of streets specified in Schedule 3 to this notice;
- (b) at any time in the lengths of streets specified in Schedule 4 to this notice. (2) Details of exemptions for certain vehicles and persons
- together with restrictions on selling or advertising in a restricted street are contained in the original Order of 1977.
