COLCHESTER BOROUGH COUNCIL

The Colchester Borough (Brook Street, High Street and Royal Square, Dedham) (Prohibition and Restriction of Waiting) Order 1995.

Notice is hereby given that Colchester Borough Council, as agents for Essex County Council, propose to make an Order under section 1 of the Road Traffic Regulation Act 1984, which will respectively:
