Notice is hereby given that the Council of the London Borough of Richmond upon Thames on 21st August 1995, made the above Orders under sections 6, 45, 46, 49, 51 and 124 of and Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended) and the Road Traffic Act 1991.

The effects of the Orders are to:

extend the Richmond Controlled Parking Zone to include *Rosemont Road* and to introduce resident's parking spaces; introduce waiting restrictions operational between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays to those lengths of *Rosemont Road* not covered by parking spaces.

The Orders will come into operation on 29th August 1995.

Notice is hereby given in accordance with the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1989, that the Council of the London Borough of Southwark, proposes to make the above-mentioned Order.

The proposed Orders would be made under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985, and of all other powers thereunto enabling.

The general effect of the Order would be to:

- add to the Southwark (Free Parking Places) (Disabled Persons) (No. 1) Order 1984 by designating a disabled persons parking place in the lengths of roads specified in the Schedule to this Notice in which vehicles authorised by the Order may be left in any period during the permitted hours without charge;
- amend the Southwark (Parking Places) (No. 1) Traffic Order 1987, in order to accommodate a disabled persons parking place by revoking and redesignating the residents parking place (number 207) on the east side of Elliott's Row.
