#### HARBOURS ACT 1964

#### Ilfracombe Harbour Revision Order

Notice is hereby given that the North Devon District Council (hereinafter referred to as "the Council") have applied to the Secretary of State for Transport to make a Harbour Revision Order under section 14 of the Harbours Act 1964.

The objects of the proposed Order are:

- (1) to authorise the Council to construct the following works (hereinafter referred to as "the works") in the parish of Ilfracombe in the district of North Devon in the county of Devon, namely a Slipway constructed of four longitudinal reinforced concrete beams supported by eight cross beams with a surface of precast concrete planks commencing at a point on the harbour wall 28 metres or thereabouts south from the junction of Hierns Lane and The Strand and extending into Ilfracombe Harbour for 49 metres with an overall width of 8 metres;
- (2) to empower the construction of subsidiary works, the alteration and improvement of works, dredging for the purpose of access to the works or the accommodation of vessels thereat and to provide limits of deviation in respect of the line or situation and level of the works;
- (3) to provide a code for the construction of tidal works including approval of the Secretary of State, safeguarding against danger to navigation, abatement of works abandonded or decayed, survey of works, lights on works during construction and permanent lights on works after construction;

(4) to provide for the removal by the Council of any vehicle or boat left in any place likely to obstruct or interfere with the use of the works or left in any part of the works where the parking of vehicles or boats is prohibited by notice erected by the Council.

(5) to empower the Council to lease or grant for harbour purposes the use or occupation of the works, to make provision for an offence of obstructing the execution of the works, the incorporation of certain provisions, with or without amendment, of the Harbours, Docks and Piers Clauses Act 1847 and to provide savings for the Crown and Trinity House.

A copy of the draft Order which-accompanied the application together with a copy of the plan and section referred to therein showing the lines and situation and levels of the works have been deposited at the offices of the Chief Executive of the Council at the Civic Centre, Barnstaple EX31 1EA and at Ilfracombe Town Council Offices, Northfield Road, Ilfracombe, Devon where they may be seen at all reasonable hours.
