"9(e) No person shall use a draft net for taking salmon, trout or freshwater fish in any waters of the River Severn which are on the seaward side of an imaginary line from Brimms Pill (OS Grid Reference SO 6900 0685) in the Parish of Awre to Middle Point (OS Grid Reference SO 7185 0570) in the Parish of Slimbridge."

The application and interpretation provisions in the Severn-Trent Region Byelaws shall apply to the above byelaw.

Review of Rod and Line Byelaws

The Welsh Region of the National Rivers Authority ("the Authority") hereby gives notice that it intends to apply on or after 20th October 1995 to the Secretary of State for Wales for confirmation of byelaws (to amend byelaws known as the "Rod and Line Byelaws 1995") made by the Authority in pursuance of powers conferred on it by Schedule 1 to the Salmon and Freshwater Fisheries Act 1975 and section 210 of and Schedule 26 to the Water Resources Act 1991.

The byelaws amend the Authority's existing Rod and Line Byelaws confirmed in 1994 ("the amended byelaws") with the effect:

- That in respect of the River Clwyd in the Authority's Welsh Region fly fishing and spinning only will be permitted from the beginning of the season until 1st June and that from 1st October until the end of the season only fly fishing will be permitted; and
 That in respect of all rivers in the West Wales Fisheries district
- (2) That in respect of all rivers in the West Wales Fisheries district of the Authority's Welsh Region the season will commence for all species (salmon, migratory and non-migratory trout) on 1st April with the exception of the Upper River Teifi (upstream of Lampeter Bridge) where the non-migratory trout season will commence as at present on 3rd March. The season for salmon and migratory trout will finish on 7th October and for non-migratory trout on 30th September. During the season all methods of fishing by means of rod and line may be used. There will be a bag limit of two salmon and four migratory trout per day and a limit of five salmon per week.
