The Surrey County Council (Parking Places and Restriction of Waiting and Loading) (Guildford) (Amendment) (No.) Order 199 .

Notice is hereby given that Surrey County Council propose to make an Order under sections 1(1) and (2), 2(1) to (3) of, and Parts III and IV of Schedule 9 to the Road Traffic Regulation Act 1984, the effect of which will be to introduce both double yellow line and single yellow line waiting restrictions in Guildford Park Avenue, Guildford, as described in the Schedules to this notice.

Part One

Guildford Park Avenue, Guildford (Outer Ring, kerb-line outside even numbered properties), Proposed No Waiting at Any Time (double yellow lines).

- (a) The west side, between the north-eastern kerb-line of Guildford Park Road, north/north-westwards for a distance of 129.5 metres (length of carriageway marked "1" on the plan).
- (b) From the prolongation of the southern boundary of No. 182 Guildford Park Avenue, being a point 168.9 metres north of the north-eastern kerb-line of Guildford Park Road, south-eastwards for a distance of 32.2 metres (length of carriageway marked "2" on the plan).
- (c) From the prolongation of the western boundary of No. 168 Guildford Park Avenue, being a point 232.1 metres north of the north-eastern kerb-line of Guildford Park Road, north-east and northwards around the most northerly of the turning heads to the prolongation of the boundary between Nos. 94-96 Guildford Park Avenue, a distance of 180 metres (length of carriageway marked "3" on the plan).
- (d) From the prolongation of the western boundary of No. 92 Guildford Park Avenue, being a point 423.1 metres north of the north-eastern kerb-line of Guildford Park Road, southwards for a distance of 39 metres (length of carriageway marked "4" on the plan).
- (e) From the prolongation of the northern boundary of No. 80 Guildford Park Avenue, being a point 490.1 metres north of the north-eastern kerb-line of Guildford Park Road, south-east/east and north-eastwards for a distance of 65 metres (length of carriageway marked "5" on the plan).
- (f) From the prolongation of the western boundary of No. 70 Guildford Park Avenue, being a point 535.1 metres north of the north-eastern kerb-line of Guildford Park Road, north and north-eastwards for a distance of 45 metres (length of carriageway marked "6" on the plan).
- (g) From the prolongation of the western boundary of No. 56 Guildford Park Avenue, being a point 554.6 metres north of the north-eastern kerb-line of Guildford Park Road, west, south and eastwards for a distance of 62 metres (length of carriageway marked "7" on the plan).

- (h) From the prolongation of the western boundary of No. 40 Guildford Park Avenue, being a point 676.6 metres north of the north-eastern kerb-line of Guildford Park Road, west and south-westwards for a distance of 32 metres (length of carriageway marked "8" on the plan).
- (i) From the prolongation of the eastern boundary of No. 8 Guildford Park Avenue, being a point 767.4 metres north of the north-eastern kerb-line of Guildford Park Road, westwards for a distance of 58 metres (length of carriageway marked "9" on the plan).

Guildford Park Avenue, Guildford (Inner Ring, kerb-line outside odd numbered properties), Proposed No Waiting at Any Time (double yellow lines).

- (a) From the prolongation of the western boundary of No. 7 Guildford Park Avenue, west/north-westwards for a distance of 31 metres (length of carriageway marked "A" on the plan).
- (b) From the prolongation of the northern boundary of No. 61 Guildford Park Avenue, north-eastwards for a distance of 34.5 metres (length of carriageway marked "B" on the plan).
- (c) From the prolongation of the western boundary of No. 55 Guildford Park Avenue, north-eastwards for a distance of 22 metres (length of carriageway marked "C" on the plan).
- (d) From the prolongation of the southern boundary of No. 41 Guildford Park Avenue, north-westwards and south-westwards for a distance of 56 metres (length of carriageway marked "D" on the plan).
- (e) From the prolongation of the northern boundary of No. 27 Guildford Park Avenue, south-westwards for a distance of 36.7 metres (length of carriageway marked "E" on the plan).

- (a) From a point 129.5 metres north of the north-eastern kerb-line of Guildford Park Road, north-eastwards for a distance of 28.4 metres (length of carriageway marked "a" on the plan).
- (b) From the prolongation of the western boundary of No. 70 Guildford Park Avenue, being a point 561.9 metres north of the north-eastern kerb-line of Guildford Park Road, east, south and westwards around the turning head, serving Nos. 56-70 Guildford Park Avenue, a distance of 59.5 metres (length of carriageway marked "b" on the plan).
- (c) From the prolongation of the western boundary of No. 54 Guildford Park Avenue, being a point 683.4 metres north of the north-eastern kerb-line of Guildford Park Road, east, south and westwards around the turning head, serving Nos. 40-54 Guildford Park Avenue, a distance of 60 metres (length of carriageway marked "c" on the plan).
- (d) From the prolongation of the western boundary of No. 30 Guildford Park Avenue, being a point 808.9 metres north of the north-eastern kerb-line of Guildford Park Road, westwards for a distance of 32.5 metres.
