- (a) To prohibit the driving or waiting of vehicles in Fore Street (south arm) from the junction with East Street/Fore Street (east arm) westwards to the junction of Fore Street (west arm)/Corporation Street.
- (b) To prohibit the driving or waiting of vehicles on the parts of the existing carriageway:
  - (i) on the north side of Corporation Street, ranging between 2.5 metres and 4 metres in width, from the junction with Fore Street north-westwards to a point directly opposite the western boundary of the Old Municipal Buildings;
  - (ii) on the south side of Corporation Street, 1 metre in width, from the junction with Fore Street north-westwards to the western boundary of the Library;
  - (iii) on the north side of *East Street*, ranging between 1.5 metres and 5.5 metres in width, from the junction with Fore Street eastwards to a point directly opposite the western boundary of the bus bay outside the former County Hotel;
  - (iv) on the south side of *East Street*, ranging between 0 metres and 10 metres in width, from the junction with Fore Street eastwards to the western boundary of the bus bay outside the former County Hotel;
  - (v) on the east side of *Fore Street*, (east arm), ranging between 10 metres and 0.5 metres in width, from the junction with North Street south-eastwards to the junction with East Street;
  - (vi) on the west side of *Fore Street*, (east arm), ranging between 2 metres and 6 metres in width, from the junction with North Street/Fore Street (west arm) southwards to the junction with Fore Street (south arm);
  - (vii) on the west side of *Fore Street*, (west arm), ranging between 1 metre and 13 metres in width, from the junction with Corporation Street north-eastwards to the junction with North Street;
  - (viii) on the east side of *Fore Street*, (west arm), ranging between 1 metres and 6 metres in width, from the junction with Corporation Street north-eastwards to the junction with Fore Street (east arm);
  - (ix) on the east side of North Street, ranging between 1 metre and 5 metres in width, from its junction with St. James Street and The Bridge southwards to the junction with Fore Street;
  - (x) on the west side of North Street, ranging between 1 metre and 2.5 metres in width, from its junction with St. James Street and The Bridge southwards to the junction with Fore Street;
  - (xi) on the west side of *The Bridge*, ranging between 0 metre and 1 metre in width, from the junction with Bridge Street southwards to the junction with St. James Street/North Street;
  - (xii) on the east side of *The Bridge*, ranging between 0 metres and 4 metres in width, from the junction with Bridge Street southwards to the junction with St. James Street/North Street;
- (c) To revoke the existing Fore Street one-way system and introduce two-way traffic along the east and west arms of Fore Street;
- (d) To introduce a one-way system in *Hammet Street* from the junction with Fore Street (east arm) eastwards for a distance of 21 metres (east to west);
- (e) To prohibit south-bound vehicles (not cyclists) from turning left into Hammet Street from Fore Street (east arm);
- (f) To prohibit north-bound vehicles (not cyclists) from turning right into Hammet Street from Fore Street (east arm);
- (g) To prohibit waiting at any time on the following lengths of road:
