Rome, March 21.

N the 9th Instant the Marquis del Borgo had Audience of the Pope, and in the Name of the King of Sicily his Master, made an Offer of some Ships of War and a Number of Land Forces, to be employed for the Defence of Christendom against the Turks: But as his Sicilian Majesty demands that the Charge of maintaining these Succours should be born by the Apostolical Chamber, the Pope has refused them. The King of Spain having offered to furnish for the same Service 6 Men of War and 4 Gallies, on his own Pay, and 3000 Land Soldiers to be paid by the Pope; the former are accepted, but the Troops refused. The Pope has also given an Audience to the Ambassadour of Portugal, on the Subject of Supplies against the Infidels; but the Conditions on which that Crown is willing to grant them, are not yet known. In the mean while 'tis given out here, that the Naval Force to be employed this Year against the Turks, will be made up in the following Manner; by the Pope, 2 Men of War and 6 Gallies; the Order of Malta, 4 Men of War and 5 Gallies; Spain, 6 Men of War and 4 Gallies; the Great Duke of Tuscany, 2 Men of War and 3 Gallies; Portugal, 8 Men of War; the Republick of Venice, 32 Men of War and 20 Gallies.

Venice, March 27. The Officers who have the publick Care of Health have paffed Sentence of Death on Joseph Papuzzi, one of their Commissaries, for taking Diamonds of great Value out of a Packet of Letters which he opened in order to their being purissed (as the Manner is when they come from Countries suspected to have any contagious Distemper) before they were distributed. He is condemned to be hanged between the Pillars in the Piazzetta near the Office della Sanita, his Effects to be consistent, and a Stone to be set up at the House where he dwelt, on which his Crime and Sentence is to be inscribed for perpetuating his Name with Insamy. By Ships arrived from Corsu we have Advice, that General

Schulembourgh is employing a confiderable Number of Men in repairing and strengthening the Fortifications of that Town and Island: When that Work is finished he is to go to Dalmatia to View the Condition of our fortified Places there, and make the most proper Disposition for the Defence of that General Gnostitz is to go from Country. hence to Corfu. Sig. Antonio Loredano is on his Departure as General of the Islands, and a good Number of Transports, with Troops, Money and Stores of War of all Kinds, will go under Convoy of two Men of War which are appointed to attend him: 3000 Germans are shortly expected here, Part of them being already arrived at Verona; and the Duke of Parma is sending hither a Regiment of 1800 Men. By Ships come in from the Levant we learn that the Turkish Fleet is to consist this Summer of 63 Ships of War, of which 31 will be Sultanas. Yesterday M. Alexander Cunningham, his Britannick Majesty's Resident to this State, made his publick Entry, the British Conul and Merchants attending, and had Audience of the Doge and Senate, with the Ceremonies used on the like Occasions.

Hambourg, April 7. Letters from Copenhagen of the 4th Instant say, Advice was brought by a Ship from Norway, that the Swedes had made an Attempt on the Castle of Aggerhuys near Christiania, but were repulsed with great Loss, and forced to retire; the Confirmation and Particlars of which Action were expected. On the 4th Vice-Admiral Gabel with his Squadron of Men of War, and some Transports, having on board the Regiments of Zeplin and Whitt-sield, sailed from Copenhagen for Frederickstad in Norway; which Regiments, immediately after landing, are to march and joyn the Body of Forces with which General Lutzau is posted near Brugeness. The Marriage of the Duke of Mecklenbourg with the Czar's Niece has been solemnized at Dantzick; whence his Czarish Majesty is preparing to set out on the 14th Instant, to proceed on his Journey into Germany.

Paris, April 6. On the 14th of this Month, a Declaration in the King's Name, by Advice of the Regent, was registred in Parliament; by which the Bills and Orders issued out of the Treasury for the Principal and Interest of Sums lent on the feveral Royal Funds, or advanced for the publick Service during the late War, are all reduced more or less on different Pretences; generally by the following Sort of Rules, viz. Such as remain in the Hands of those Persons to whom they were originally issued, for the Loans or Advances in Specie actually made by them, are reduced One Fifth; those which have been issued to Persons upon Contracts in which they are supposed to have had an Advantage above the common Interest of Money, are reduced some to Three, others to Two Fifths; and such as have passed through divers Hands, and been often bought and fold at Discount, are reduced to One Fifth.

Hague, April 10. The States General having resolved upon their Quota of Men of War intended to compose a Squadron jointly with those of Great Britain, for the Security of the Trade of both Nations in the Baltick, have, for the more ready Equipment of those Ships, impowered the feveral Colleges of the Admiralty concerned therein, to borrow the Sum of Four hundred thousand Florins at 4 per Cent. We are now expecting the Resolutions of the Court of Great Britain, as to their Contingent, which according to the Repartition, established by Treaty, is to bear the Proportion of five Ships to three. The Envoy from this State to the Court of Denmark, who has been absent from his Post these two Years, is now ordered to hasten thither. Our Letters from Vienna tell us, that the Empress continued in very good Health, and reck-oned to lie in about Easter; and that Count Trautmansdorff who was the Imperial Ambasfador in Swifferland during the last War, was returned from that Employment. Some Advices from Constantinople say, that the Ottomon Port had declared they would look upon as Enemies all fuch as should give any Assistance to the Venetians directly or indirectly. By Letters from Paris of the 6th we learn, that the Duke of Ossuna, who was one of the Plenipotentiaries on the Part of Spain at the Treaty of Utrecht, being thought in a good way of Recovery from a dangerous Fit of Sickness, relapsed and dyed there on the 3d.
