#### UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

A Statute made by the Governing Body of the Linacre College in the University of Oxford, on 9th November 1995, amending Statutes IV and V, has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923.

The purpose of the Statute is to amend the provisions governing the appointment of a new Principal; to allow the Governing Body to create categories of fellowship at its own discretion; and to amend procedure for dealing with misconduct by a Fellow. (1 SI)
