

The general nature and effect of the Order will be to amend the Barnet (Waiting and Loading Restriction) (Special Parking Area) Order 1994, so that additional or amended restrictions are placed on waiting and loading by vehicles in the lengths of carriageway specified in the Schedule to this notice.

LONDON BOROUGH OF BARNET

The Barnet (Waiting and Loading Restriction) (Special Parking Area) Amendment No.) Order 1995, the Barnet and Brent (Restriction of Waiting on Bus Stops) (No. 1, 1974) (Amendment No.) Traffic Order 1995 and the Barnet (Greater London, Prohibition of Stopping on Cab Ranks) (Amendment No.) Traffic Order 1995.

Notice is hereby given that the Council of the London Borough of Barnet propose to make the above-mentioned Orders under sections 6 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

The general nature and effect of the Orders would be as follows: (a) the Waiting and Loading Restriction Amendment Order would amend the Barnet (Waiting and Loading Restriction) (Special Parking Area) Order 1994 so that:

(i) the times during which the existing restrictions on waiting by vehicles apply in the lengths of streets specified in Schedule 1 to this notice would be changed at the times stated in column 2 of that Schedule;
