*The Borough Council of Gateshead (Gainford "Loop" Road, Allerdene) (Prohibition of Driving) Order 1995*

*The Borough Council of Gateshead (Black Walker Terrace/Back Regent Terrace, Gateshead) (Waiting Restrictions) Order 1995*

#### MID GLAMORGAN COUNTY COUNCIL

*Mid Glamorgan County Council (Gethin Road, Treorchy) Experimental (One-way Traffic) Order 1995*

Notice is hereby given that on 6th December 1995 the Mid Glamorgan County Council made an Order under sections 9 and 10 of the Road Traffic Regulation Act 1994, the effect of which is to experimentally, for a period of 18 months prohibit any person, except upon the direction or with the permission of a police constable in uniform, from causing any vehicle to proceed in the length of road specified in column 1 of the Schedule to this notice in a direction other than that specified in relation to the length of road in Column 2 of the said Schedule.

An exemption is provided in the Order to enable a mechanical road cleansing vehicle to operate during certain hours.

The Order shall be operative from 14th December 1995, and a copy thereof and a map showing the length of road to which the Order relates together with a statement of reasons for the County Council making the Order may be inspected, at the offices of the Mid Glamorgan County Council, Cathays Park, Cardiff during normal office hours.

The Highway Authority at the time shall be considering in due course whether the provisions of the Order shall continue in force indefinitely. Objections to the proposal, together with the grounds on which they are made must be sent in writing within 6 months from 14th December 1995. Up to and including 31st March 1996 any such objections should be sent to the undersigned, and thereafter to the succeeding appropriate officer of the Rhonda Cynon Taff County Borough Council.

The County Secretary and Solicitor may provide for the suspension or modification of the Order or part thereof, while it is in force if it appears that it is essential in the interests of the expeditious, convenient and safe movement of traffic, or of the provision of suitable and adequate parking facilities on the highway, or for preserving or improving the amenities of the area through which any road affected by the Order runs.

Any persons wishing to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order, may within 6 weeks from 6th December 1995 apply to the High Court for this purpose.
