Public Bridleway No. 18 Aston cum Aughton Parish/No. 9 Thurcroft Parish and Public Footpath No. 17 Aston cum Aughton Parish Crossing the Proposed "Straight Mile Landfill" site Brampton en le Morthen, Rotherham

Notice is hereby given that the Secretary of State for the Environment, in exercise of the powers conferred on him by sections 247 and 253 of the Town and Country Planning Act 1990 and all other powers enabling him in that behalf, proposes to make two orders the effect of which will be to divert:

(i) Bridleway No. 9 Thurcroft Parish which commences at Long Road, close to its junction with Penny Hill Lane and Hawk Hill Lane, and proceeds in a south westerly direction to the Aston-cum-Aughton Parish Boundary and a section of Bridleway No. 18 commencing at the Thurcroft Parish boundary and proceeding in a south-westerly direction to its junction with the County Road at Vessey Close Farm thence continuing to its junction with public footpath No. 16, and

(ii) A section of footpath No. 17 commencing at its junction with Hardwick Lane County Road and proceeding in a northeasterly direction to the Thurcroft Parish boundary.
