# WATER INDUSTRY ACT 1991: SECTION 19(1)(b)

Consumers in Reading and the surrounding areas who may be affected by improvement work being carried out by Thames Water Utilities Limited at its Compton Water Treatment Works will wish to be aware of the following information.

Although the water has at all times been, and remains, safe to drink, the Company has found from its water quality monitoring programme that water supplied from this works has on occasion not met the standard for nitrate (as required by the Water Supply (Water

Quality) Regulations 1989).

The Company gave the Secretary of State for the Environment a legally binding undertaking on 7th October 1993, to carry out remedial work (to be completed by 30th June 1996). In the light of advice received after giving that undertaking the Company has found it necessary to modify the steps to be taken. The Company has therefore submitted a further undertaking with the same completion date of 30th June 1996.

The Secretary of State is satisfied that the Company is complying with this new agreement and has informed the Company that he is satisfied by serving on them the notice printed below:

## WATER INDUSTRY ACT 1991: SECTION 19(1)(B)

The Secretary of State for the Environment:

- Is satisfied that Thames Water Utilities Limited "the Company"
   when supplying water from its Compton Water Treatment Works has contravened and is likely to do so again its duty to supply wholesome water under section 68(1)(a) of the Water Industry Act 1991, and the requirement of Regulation 3(3)(c) of the Water Supply (Water Quality) Regulations 1989, that water supplied should not contain nitrate at a greater concentration than 50mg/l.
- 2. Notes that Thames Water Utilities Limited has on 30th November 1995 given a new undertaking to replace that undertaking given on 7th October 1993 (reference no: 085) and take the following steps by the dates shown:
- (a) Carry out mains laying to enable the area to be supplied reliably from the Cleeve works. To be completed by 30th June.
- (b) Close Compton works. To be completed by 30th June 1996.
