In his Notice of 24th November 1995, the Secretary of State for Foreign and Commonwealth Affairs gave notice that, by resolution 1022 (1995) adopted on 22nd November 1995, the Security Council of the United Nations had declined to suspend indefinitely the operation of the measures imposed by resolutions 757 (1992), 820 (1993), 942 (1994) and other relevant resolutions, which imposed certain measures in relation to Serbia and Montenegro and the United Nations Protected Areas of the Republic of Croatia, with the exception that certain assets frozen or impounded pursuant to resolutions 757 (1992) and 820 (1993) shall remain frozen or impounded as provided in paragraph 5 of resolution 1022 (1995).

Pursuant to the provisions of Article 1(2) of the above-mentioned Orders, the Secretary of State hereby gives notice that the suspension is extended, with effect from 27th February 1996, to the measures imposed by the said resolution in relation to the areas of Bosnia and Hertzegovina controlled by the Bosnian Serb forces.

By resolution 1022 (1995) the Security Council further decided that, on the occurrence of certain events specified in the resolution, (a) the measures would be automatically reimposed, or (b) the measures would be cancelled. In either of these cases a further notice will be issued

By resolution 1022 (1995) the Security Council further decides that States shall continue to ensure that there shall be no claim in connection with the performance of any contract or other transaction where such performance was affected by the measures imposed by the resolutions referred to above and related resolutions.

In accordance with the provisions of the said Article 1(2), the operation of the above-mentioned Orders was therefore suspended indefinitely with effect from 27th February 1996 in respect of the measures imposed in relation to the areas of Bosnia and Herzegovina controlled by the Bosnian Serb forces.
