### NOTICE OF PUBLIC PATH DIVERSION ORDER TOWN AND COUNTRY PLANNING ACT 1990

*The Borough of Warrington, Penketh Parish, Public Path No. 25  
 Diversion Order 1996*

Notice is hereby given that the Secretary of State for the Environment, in exercise of the powers conferred on him by sections 247 and 253 of the Town and Country Planning Act 1990 and all other powers enabling him in that behalf, if planning permission is granted for secondary mineral extraction at the Bob's Bridge Sand Extraction Site, Moore Land, Moore, Cheshire, proposes to make an Order the effect of which will be to divert that part of Footpath No. 25 Penketh, which runs from the western side of Lapwing Lane generally west to its junction with Footpath No. 2 Cuedley.

The lines and situations of the existing and proposed alternative highways are shown on the map annexed to the Order.

A copy of the draft Order and the map contained in it may be inspected by any person free of charge at the office of Warrington Borough Council, Community Services, West Annexe, Town Hall, Warrington WA1 1UH at all reasonable hours during a period of 28 days from 1st March 1996.

Any person may within that period object to the Order by notice in writing to the Secretary of State for the Environment at Government Office for the North West, Room 1113, Sunley Tower, Piccadilly Plaza, Manchester M1 4BE, quoting reference PNW/5046/151/9 and should clearly state the grounds on which objection is made.

### TOWN AND COUNTRY PLANNING ACT 1990

*The Stopping Up of Highways (County of Norfolk) (No. 2)  
 Order 1996*

The Secretary of State for Transport hereby gives notice that, on the application of Great Yarmouth Borough Council, he has made an Order under section 247 of the above Act entitled "The Stopping Up of Highways (County of Norfolk) (No. 2) Order 1996" authorising the stopping up of an area of all-purpose highway, known as Russell Road Bleach at Great Yarmouth in Norfolk to enable development consisting of the change of use from Bleaches, within the highway, to car parking and drying areas to be carried out in accordance with the planning permission granted to and by Great Yarmouth Borough Council on 21st February 1992 under reference 06/92/0135.SU.

Copies of the Order may be obtained, free of charge, on application to the Government Office for Eastern Region (Transport), Heron House, 49-53 Goldington Road, Bedford MK40 3LL (quoting reference GTU2615/35/1/01) and may be inspected at all reasonable hours at the offices of Great Yarmouth Borough Council, Town Hall, Great Yarmouth.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 1st March 1996 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
