NORTHUMBERLAND COUNTY COUNCIL**HIGHWAYS ACT 1980, SECTION 116***Notice of intention to apply for an Order for stopping-up a highway at Eighth Avenue, Blyth*

Notice is given that application will be made to the Magistrates Court sitting at Bedlington in the county of Northumberland, at 2 p.m., on Thursday, 25th April 1996, for an Order that the highway in the Borough of Blyth, Northumberland, leading from Eighth Avenue, Blyth, to the allotment gardens situated at the rear of part of Eighth Avenue, Blyth, shall be stopped up in the following manner on the grounds that it is unnecessary:

Notice is given that application will be made to the Magistrates Court sitting at Bedlington in the county of Northumberland, at 2 p.m., on Thursday, 25th April 1996, for an Order that the highway in the Borough of Blyth, Northumberland, situated at South View, Blyth, leading from South View to the waste land at the rear of numbers 11 and 13 South View, Blyth, shall be stopped up in the following manner on the grounds that it is unnecessary:
