CUMBRIA COUNTY COUNCIL

The County of Cumbria (New Lowther Street, Whitehaven) (Provision of Street Parking Places, Prohibition of Waiting and Consolidation of Traffic Regulations) Order 199 .

Notice is hereby given that Cumbria County Council propose to make an Order under sections 1, 2, 4, 32, 35 and Parts III and IV of Schedule 9 to the Road Traffic Regulation Act 1984.

The following is a summary of the traffic regulations in respect of New Lothar Street, Whitehaven. Please refer to the document on deposit for further details:

- (1) Consolidation of existing traffic regulations;
- (2) Revocation of existing echelon parking places on the north-east side and provision of Disc Parking Places parallel to the kerb between 8.30 a.m. and 6 p.m. Monday to Saturday inclusive waiting limited to 1 hour return prohibited within 1 hour;
- (3) Revocation of existing No Waiting at Any Time on the south-west side and provision of Disc Parking Places parallel to the kerb between 8.30 a.m. and 6 p.m. Monday to Saturday inclusive waiting limited to 1 hour return prohibited within 1 hour;
- (4) Revocation of existing echelon Disabled Parking Place on the north-east side and provision of Disabled Parking Place parallel to the kerb on the south-west side;
- (5) Exemption to the time limits for parking referred to in (2) and (3) above for residents of New Lowther Street and Bells Place with provision also for visitors and carers;
- (6) Provision a of turning area at the western end on the north-east side of New Lowther Street which necessitates provision of No Waiting at Any Time.

The proposal will include part revocation of existing Orders covering the above-named road.

If you wish to object to the proposed Order, bearing in mind that you can only object to any new proposals, you should send the grounds for your objection in writing to the undersigned by 12th April 1996.

The County of Cumbria (A6 Hackthorpe) (40 m.p.h. Speed Limit) Order 1996
