UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

A Statute made by the Governing Body of St. Edmund Hall, in the University of Oxford, on 15th March 1996, amending Statutes IV and V, has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923.

The purposes of the Statute are to alter, in certain circumstances, the retirement age of the Principal, and to change the period for which an Official Fellow is elected. (8 SI)
