#### **TOWN AND COUNTRY PLANNING ACT 1990**

Highways at Stockfield Estate, Acocks Green, Birminghum

The Secretary of State for Transport hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping-up of Highways (City of Birmingham) (No. 3) Order 199", authorising the stopping-up of lengths of highway at Stockfield Estate, Acocks Green, Birmingham, and requiring the provision of new highway shown as stippled on the deposited plan and the improvement of existing highway shown as cross hatched on the deposited plan.

The Order as made, will authorise the stopping-up only to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted by Birmingham City Council on 13th July 1995, and under ref. E/05193/94/FUL.

validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the above Act, or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may within 6 weeks of 1st April 1996, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
