### SUTTON AND EAST SURREY WATER PLC

#### *Notice under Section 20, Water Industry Act 1991*

This notice affects consumers of Sutton and East Surrey Water plc in the Horley, Reigate, Edenbridge, Lingfield and surrounding areas supplied by the Bough Beech Water Treatment Works.

A recent advertisement gave notice that the Secretary of State for the Environment proposed to make a Final Enforcement Order under section 18 of the Water Industry Act 1991 requiring the Company to complete the construction and operate an aeration plant at Bough Beech works to remove halomethanes.

The Company made a formal objection to the proposed Order which was not accepted by the Secretary of State. The Company was informed that the Order would be made if the work was not completed by Friday, 26th April 1996.

An Inspector from the Drinking Water Inspectorate attended the Bough Beech Works on 26th April 1996. The Inspectorate is pleased to advise that Sutton and East Surrey Water had completed the construction of the aeration plant by that date and that it is operating satisfactorily. A Final Enforcement Order will not now be necessary.

#### *Proposed Stopping-up of Highway at Kirkham*

### TOWN AND COUNTRY PLANNING ACT 1990

#### *The Stopping-Up of Highways (County of Norfolk) (No. 3) Order 1996*

(4 SI)

The Secretary of State for Transport hereby gives notice that, on the application of Mills and Reeve, Solicitors, he has made an Order under section 247 of the above Act entitled "The Stopping-Up of Highways (County of Norfolk) (No. 3) Order 1996" authorising the stopping-up of a length of unnamed highway adjoining Station Road at Hoveton, Norfolk, to enable development consisting of construction of department store, new access road and service delivery area, and amended car park layout at Roys, Stalham Road, Hoveton, to be carried out in accordance with the planning permission granted to Roys (Wroxham) Limited by North Norfolk District Council on 8th September 1995 under Ref. 01950834PF.

The Order requires an improvement of a length of unnamed highway between Tunstead Road and Stalham Road and an area of highway at the junction of the unnamed highway mentioned in paragraph 1 at its junction with Station Road, and the provision of a new highway maintainable at the public expense for which Norfolk County Council will be the local highway authority.

The Order provides that the stopping-up must not be carried out until Roys (Wroxham) Limited has improved the aforementioned highway, provided the new highway and that the new highway and the improved highway shall be highways maintainable at the public expense for which Essex County Council will be the local authority.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 1st May 1996, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
