#### TOWN AND COUNTRY PLANNING ACT 1990

The Stopping-up of Highways (The A5 Trunk Road, Victoria Road, Holyhead, Isle of Anglesey) Order 199

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 247 of the Town and Country Planning Act 1990, to authorise the stopping-up of the areas of highway described in the Schedule to this notice.

If the Order is made, the stopping-up will be authorised only in order to enable development consisting of the erection of a security fence, in association with the Holyhead (Salt Island) port development, to be carried out in accordance with planning permission granted by Isle of Anglesey Borough Council on 8th May 1996, under reference 19C645.

During the 28 days from 6th June 1996, copies of the draft Order and the deposited plan may be inspected during normal opening hours (9 a.m. to 5.30 p.m. Monday to Thursday, 9.30 a.m. to 5.30 p.m. Fridays and 9 a.m. to 12.30 p.m. Saturdays) at Holyhead Post Office, Branch Office, 13A Boston Street, Holyhead, or may be obtained, free of charge, from the address below quoting the Welsh Office Reference.

Withing the above-mentioned period of 28 days any person may, by notice to the Welsh Office, Highways Directorate, Roads Administration Division, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, (quoting reference ZC 510-54-15), object to the making of the Order. In the preparation of an objection if should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

#### SCHEDULE

#### (All measurements are approximate)

The areas of highway to be stopped up form part of the A5 London-Holyhead Trunk Road, known as Victoria Road, at Holyhead, in the county of Isle of Anglesey. They are shown by zebra hatching on the deposited plan, are situated immediately south-west of the southern abutment of Pelham Patch Bridge and comprise:

i. an irregular shaped area of carriageway which extends in a south-westerly direction for a distance of 21 metres, having a maximum width of 9 metres and a total area of 152 square metres; and

 a wedge shaped area of adjoining carriageway which extends in a south-westerly direction for a distance of 23 metres, its maximum width of 2 metres being at its north-eastern end and a total area of 20 square metres. (481)

#### WATER INDUSTRY ACT 1991: SECTION 19(1)(b)

Consumers in the Neath, Dulais, Maesteg, Llynfi and Afan Valleys who might be affected by improvement work being carried out by Dŵr Cymru Cyfyngedig at its Ystradfellte Water Treatment Works, will wish to be aware of the following information.

Although the water has at all times been, and remains, safe to drink, the treatment afforded to the raw water source has not been sufficient to comply with the minimum level of treatment required by regulation 23(2) of the Water Supply (Water Quality) Regulations 1989.

The Company gave the Secretary of State for Wales a legally binding undertaking on 12th April 1996, to carry out preliminary work at Ystradfellte Water Treatment Works (to be completed by 31st March 1996. However due to reasons beyond the Company's control it has had to submit a further undertaking with a completion date of 31st December 1996.

The Secretary of State is satisfied that the Company is complying with this new agreement and has informed the Company that he is satisfied by serving on them the notice printed below.

#### WATER INDUSTRY ACT 1991: SECTION 19(1)(B)

#### The Secretary of State for Wales:

- 1. Is satisfied that Dŵr Cymru Cyfyngedig "the Company", in supplying water from the Ystradfellte Water Treatment Works has contravened and is likely to do so again its duty to supply wholesome water under section 68(1)(a) of the Water Industry Act 1991, and the requirement of Regulation 23(2) of the Water Supply (Water Quality) Regulations 1989, that the Company shall not supply water from any surface water source which has been afforded such treatment as is required to secure compliance with Council Directive 75/440/EEC, that is the quality required of suface water for the abstraction of drinking water.
- 2. Notes that Dŵr Cymru Cyfyngedig has on 25th March 1996, given a new undertaking which replaces that undertaking given on 12th April 1994 (Reference No. DC 018) to take the following steps by the dates shown:
