WATER INDUSTRY ACT 1991—SECTION 19

Consumers in the Chirk and Pentre areas who might be affected by improvement work being carried out by Wrexham Water plc at its New Hall service reservoir will wish to be aware of the following information.

Although the water has at all times been, and remains, safe to drink the Company has found through its water quality monitoring programme that water supplied from this reservoir has on occasion not met the standard for faecal coliforms (as required by the Water Supply (Water Quality) Regulations 1989). The Secretary of State for Wales, therefore, notified the Company that he will, if necessary, order the Company to take appropriate steps to ensure that the water supplied will in future meet the required standard.

The Company has given the Secretary of State a legally binding undertaking to carry out appropriate remedial work at New Hall service reservoir to be completed by 31st August 1996. The Secretary of State has informed the Company that he is satisfied it is complying with this undertaking, by serving on them the following notice:

WATER INDUSTRY ACT 1991—SECTION 19

The Secretary of State for Wales:

1. is satisfied that Wrexham Water plc "the Company" in supplying water from New Hall service reservoir has contravened and is likely to do so again its duty to supply wholesome water under section 68(1)(a) of the Water Industry Act 1991, and the requirement of regulation 3(7) of the Water Supply (Water Quality) Regulations 1989 that water supplied should not contain faecal coliforms.
2. has notified the Company on 2nd April 1996 that he is considering making in relation to the Company an enforcement Order under section 18 of the Water Industry Act 1991.
3. notes that the Company has on 23rd April 1996 given an undertaking under section 19(1)(b) of the Water Industry Act 1991 to take the following steps by the dates shown:
 - (a) Weekly manual chlorination. To be carried out for the duration of the undertaking.
 - (b) Weekly bacteriological samples taken and analysed, in addition to the compliance samples, 2-4 days after chlorination. To be carried out for the duration of the undertaking.
 - (c) Carry out structural repairs to the reservoir roof including the installation of an impermeable membrane. To be completed by 31st August 1996.
4. is satisfied that the Company has given and is complying with an undertaking to take all such steps as appear to the Secretary of State for the time being to be appropriate to secure or facilitate compliance with the requirement of regulation 3(7) of the Water Supply (Water Quality) Regulations 1989 that water supplied should not contain faecal coliforms.
