PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975

Notice of the issue of a submarine pipe-line works authorisation

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by Mobil North Sea Limited, whose address is Mobil Court, 3 Clements Inn, London WC2A 2EB for the construction of two 168.3 mm pipelines between Beryl 'B' installation and Beryl subsea well cluster (BWISS).

Except with the consent of the Secretary of State, the pipelines shall only be used to convey injection water.

The pipelines may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.

Mobil North Sea Limited has been appointed operator of the pipelines.

TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping-Up of Highways (County of Nottinghamshire) (No. 6) Order 1996", authorising the stopping-up of a length of highway at Cairns Street, Nottingham, measuring 1,325 square metres, from a point 26 metres south-west of the junction with Huntingdon Street in a south-westerly direction for a maximum distance of 78 metres.

The stopping-up is authorised only in order to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted to the Victoria Centre Partnership by Nottingham City Council, on 14th August 1995, under reference PF/95.04.0091.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 17th June 1996, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
