TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice the he has made an Order under section 247 of the above Act entitled "The Stopping Up of Highways (County of Hampshire) (No. 12) Order 1996", authorising the stopping up of highway land adjacent to 96 Locksway Road, Milton, Portsmouth in the county of Hampshire.

of 18th June 1996, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the stopping up of three areas of highway at Wolston Close and an area of highway at Holme Lane, Holmewood, Bradford.
