## ESSEX COUNTY COUNCIL

*Essex County Council (A604 Hedingham Road and Box Mill Lane, Halstead) (Prohibition of Waiting) Order 199*

Notice is hereby given that the Essex County Council proposes to make the above Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984.

Effect of the Order: To vary the existing Order so as to introduce no waiting at any time in the following length of road at Halstead:

A604 Hedingham Road, north-east side, from a point 34 metres south-east of its junction with Box Mill Lane north-westwards for a distance of 61 metres to a point 15 metres north-west of that junction.

The Order will revoke the Essex County Council (A604 Hedingham Road and Box Mill Lane, Halstead) (Prohibition of Waiting) Order 1995: However, the provisions contained in that Order and not mentioned above will remain in force unchanged by virtue of the new Order.
