HEREFORD AND WORCESTER COUNTY COUNCIL

The Hereford and Worcester County Council (Avenue Road and Barnards Green Traffic Island, Malvern) (Prohibition of Waiting) Order 1996.

Notice is hereby given that Hereford and Worcester County Council are to consider making an Order which will prohibit waiting at any time on the following lengths of roads:

Avenue Road, south side, from its junction with Barnards Green Road for a distance of 60 metres in a westerly direction;

Barnards Green Traffic Island, the west side of the western carriageway, from its junction with Avenue Road for a distance of 13 metres in a southerly direction.

The Order will contain exemptions to allow parking for certain purposes and limited waiting by disabled persons vehicles.

(C2232 Grange Road, Malvern) (Street Parking Places) Order 1996

On 13th June 1996, Hereford and Worcester County Council made an Order which will make permanent the existing Experimental Order. The Order will increase the period for which a vehicle may wait from two to three hours and change the hours of operation from 8 a.m. to 6 p.m. to 10 a.m. to 6 p.m. The Order will come into operation on 24th June 1996.

A copy of the Order, relevant map, statement of reasons for making the Order and affected existing regulations may be inspected at County Hall, Spetchley Road, Worcester WR5 2NP, during normal office hours.

The validity of the Council's powers in making the Order or this exercise of them may be questioned by application to the High Court by 25th July 1996.

(West Waterside, Upton-upon-Severn) (Prohibition of Driving) Order 1996

On 13th June 1996, Hereford and Worcester County Council made an Order which will prohibit any vehicle from proceeding or waiting on West Waterside, Upton-upon-Severn from its junction with Church Street to its junction with Lower High Street. The Order will come into operation on 28th June 1996.

The Order contains exemptions to allow access for certain purposes and for residents of West Waterside who display a permit available from the County Council.

A copy of the Order, relevant map and statement of reasons for making the Order may be inspected at County Hall, Spetchley Road, Worcester WR5 2NP, during normal office hours.

The validity of the Council's powers in making the Order or this exercise of them may be questioned by application to the High Court by 25th July 1996.

(West Waterside, Upton-upon-Severn) (Experimental) (One-way Traffic and Prohibition of Right-hand Turn) Order 1996

On 13th June 1996, Hereford and Worcester County Council made an Experimental Order which will:

- (a) make West Waterside, Upton-upon-Severn one-way operating north to south from its junction with Church Street for a distance of 5 metres in a northerly direction. The Order will not apply to road cleansing vehicles;
- (b) prohibit any vehicle from turning right out of West Waterside into Church Street.

The Experimental Order will come into operation on 28th June 1996, and remain in force for a maximum period of 18 months.
