Only objectors whose objections are made in writing and sent to the address specified above within the 6 week period ending on 29th July 1996 will have the right to have their objections considered at a local inquiry.

If no objections are received during the period given for making objections Torfaen County Borough Council intend to adopt the proposals on the expiry of that period.
