The Dolgellau-South of Birkenhead Trunk Road (A494) (Drws y Nant Improvement) Order 1996

The Dolgellau-South of Birkenhead Trunk Road (A494) (Drws y Nant Improvement Side Roads) Order 1996 .

The Secretary of State for Wales hereby gives notice that he has made the following Orders:

1. An Order under section 10 of the Highways Act 1980 providing that a road about 0.37 kilometres in length which he proposes to construct at Drws y Nant, Dolgellau starting at a point on the Dolgellau to South of Birkenhead Trunk Road (A494) 374 metres south-west of Pont Drws y Nant and terminating at a point on the Trunk Road at the north-west corner of Pont Drws y Nant in Gwynedd shall become a trunk road as from the date when the Order comes into force; and

(NOTE: All distances of commencement and termination shown above are measured along the centre line of the existing trunk road). 2. An Order under sections 14, 125 and 268 of the Highways Act 1980 authorising him:

- (a) to improve, raise, lower or otherwise alter highways;
- (b) to stop up highways;
- (c) to construct new highways;
- (d) to stop up private means of access to premises; and
- (e) to provide new means of access to premises,

all at Drws y Nant, Dolgellau in Gwynedd, and providing for the transfer of the said new highways to the Council of Gwynedd as from the date on which he notifies the Council that the new highways have been completed and are open for through traffic.

Copies of the Orders and of the relevant plans may be inspected, free of charge, at all reasonable hours from 27th June 1996, or within 6 weeks from the date of publication of this notice, whichever period shall expire later, at:

- (i) Welsh Office Highways Directorate, Roads Administration Division, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff;
- (ii) Welsh Office Highways Directorate, Government Buildings, Dinerth Road, Colwyn Bay;
- (iii) Gwynedd Council, County Offices, Shirehall Street, Caernarfon, Gwynedd;
- (iv) Gwynedd Council, Penarlag, Dolgellau, Gywnedd; and
- (v) Llanuwchllyn Post Office, Dolgellau, Gwynedd.

Any person aggrieved by either of the Orders and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980, or on the ground that any requirement of that Act, or of regulations made thereunder, has not been complied with in relation to either of the Orders, may, within 6 weeks from 27th June 1996, or within 6 weeks from the date of publication of this notice, if such period shall expire later, apply to the High Court for the suspension or quashing of the Orders or of any provision contained therein.
