

The Orders will come into operation on 1st July 1996.

The Orders contains exemptions to allow parking for certain purposes.

The validity of the Council's powers in making the Orders or this exercise of them may be questioned by application to the High Court by 1st August 1996.

(Ferrers Street, Hereford) (One-Way Traffic) Order 1996

On 20th June 1996 Hereford and Worcester County Council made an Order which will make Ferrers Street, Hereford between its junctions with Castle Street and East Street one-way operating south to north. The Order will come into operation on 1st July 1996.

The Order will not apply to road cleansing vehicles.

A copy of the Order, relevant map and statement of reasons for making the Order may be inspected at County Hall, Spetchley Road, Worcester WR5 2NP, during normal office hours.

The validity of the Council's powers in making the Orders or this exercise of them may be questioned by application to the High Court by 1st August 1996.

(St. Owen Street, Hereford) (Bus Stop) (Clearway) (No. 6) Order 1996

On 20th June 1996 Hereford and Worcester County Council made an Order which will prohibit any vehicle, except public service vehicles, from waiting between the hours of 7 a.m. and 7 p.m. at any marked bus stops on the south-west side of St. Owen Street, Hereford from a point 25 metres south-east of its junction with the centre line of St. Owen Gate for a distance of 18 metres in a south-easterly direction. The Order will come into operation on 1st July 1996.

The Order contains exemptions to allow parking for certain.

A copy of the Order, relevant map and statement of reasons for making the Order may be inspected at County Hall, Spetchley Road, Worcester WR5 2NP, during normal office hours.

The validity of the Council's powers in making the Orders or this exercise of them may be questioned by application to the High Court by 1st August 1996.

(Grove Street, Redditch) (One-Way Traffic) Order 1996

Hereford and Worcester County Council are to consider making an Order which will make Grove Street, Redditch one-way operating south-west to north-east between its junctions with Red Lion Street and Archer Road. The Order will not apply to road cleansing vehicles.

A copy of the draft Order, relevant map and statement of reasons for proposing to make the Order may be inspected at Redditch Borough Council Offices, Town Hall, Alcester Street, Redditch and County Hall, Spetchley Road, Worcester WR5 2NP, during normal office hours. (Lyndenwood, Redditch) (Prohibition of Waiting) Order 1996

Hereford and Worcester County Council are to consider making an Order which will prohibit waiting at any time on the following lengths of Lyndenwood, Redditch:

1. north-west side, from its junction with Downsell Road for a distance of 13.9 metres in a north-easterly direction;
2. south-east side, from its junction with Downsell Road for a distance of 10 metres in a north-easterly direction.

The Order will contain exemptions to allow parking for certain purposes and limited waiting by disabled persons' vehicles.

A copy of the draft Order, relevant map and statement of reasons for proposing to make the Order may be inspected at Redditch Borough Council Offices, Town Hall, Alcester Street, Redditch and County Hall, Spetchley Road, Worcester WR5 2NP, during normal office hours. (Salters Lane, Redditch) (Prohibition of Driving) Order 1996

Hereford and Worcester County Council are to consider making an Order which will prohibit any vehicle from proceeding or waiting on the following lengths of Salters Lane, Redditch:

1. from its junction with Brockhill Lane for a distance of 25 metres in a westerly direction;
2. from its junction with Hazel Road for a distance of 15 metres in an easterly direction.

(Victoria Street, Wellington Street and Peakman Street, Redditch) (Various One-Way Traffic Orders) (Variation) Order 1996

Hereford and Worcester County Council are to consider making an Order which will vary the existing One-Way Traffic Orders and make Victoria Street, Wellington Street from its junction with Peakman Street and a point 61 metres south-east of that junction and Peakman Street between its junctions with Wellington Street and Victoria Street open to two-way traffic.

KIRKLEES METROPOLITAN COUNCIL

Kirklees Metropolitan Council (Traffic Regulation) (No. 39) Order 1994

Poplar Terrace, Moldgreen, Huddersfield

Notice is hereby given that the Kirklees Metropolitan Council made the above-named Order on 24th June 1996, under their powers in the Road Traffic Regulation Act 1984, the effect of which is to prohibit waiting by vehicles between the hours of 8 a.m. and 6 p.m. on Mondays to Saturdays in the length of Poplar Terrace (south side), Moldgreen, Huddersfield, which extends from The Avenue for 10 metres in an easterly direction.

The Order will come into operation on Monday, 8th July 1996.

A copy of the Order, together with a plan showing the affected length of road may be examined during normal office hours at Reception, Ground Floor, Highways Service, Flint Street, Fartown, Huddersfield, and at Reception, Legal Services, 2nd Floor, Civic Centre III, High Street, Huddersfield.

If you wish to question the validity of the Order, or of any provisions contained therein, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any Instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date on which the Order was made (i.e. 5th August 1996), apply to the High Court for this purpose.
