Is satisfied that the Company has given and is complying with an undertaking to take all such steps as appear to the Secretary of State for the time being to be appropriate to secure or facilitate compliance with the requirement of regulations 3(3)(c) of the Water Supply (Water Quality) Regulations 1989.

Consumers in Hartley Wintney, East Meon, Long Sutton, Popham, Alton, Aldershot, Binstead, Ellisfield, Ash, Basingstoke and Ropley, Frensham, Putterham and Maidenhead who might be affected by improvement work being carried out by Mid Southern Water plc will

wish to be aware of the following information.

Although the water has at all times been, and remains, safe to drink, the Company has found through its water quality monitoring programme that water received by consumers in these areas has on occasion not met the standards for certain parameters (normally those associated with occasional occurrences of discoloured water), as required by the Water Supply (Water Quality) Regulations 1989, because of deficiencies in the distribution system.

The Company gave a legally binding undertaking on 10th January 1990 to carry out appropriate remedial work, as the first stage of a long term programme, to refurbish affected parts of the

distribution system.
