

met the standard for total coliforms (as required by the Water Supply (Water Quality) Regulations 1989).

The Company gave the Secretary of State a legally binding undertaking on 7th August 1995, to carry out appropriate remedial work at the works (to be completed by 31st May 1996). However, for reasons beyond the Company's control, it has not been able to complete the work. Therefore the Company has submitted a further undertaking, with a completion date of 12th July 1996.

The Secretary of State is satisfied that the Company is complying with this new agreement and has informed the Company that he is satisfied by serving on them the notice printed below:

#### WATER INDUSTRY ACT 1991, SECTION 19(1)(b)

1. is satisfied that Wessex Water Services Limited "the Company" in supplying water from the Woolcombe Water Treatment Works has contravened and is likely to do so again its duty to supply wholesome water under section 68(1)(a) of the Water Industry Act 1991, and the requirement of Regulation 3(7) of the Water Supply (Water Quality) Regulations 1989, that water supplied should not contain total coliforms.

2. notes that Wessex Water Services Limited has on 17th May 1996, given a new undertaking under the provisions of paragraph 2 of that undertaking given on 7th August 1995 (Ref. No. WS 089), to replace that undertaking and to take the following steps by the dates shown:

1. Carry out the work detailed below in order to increase chlorine contact time and to improve control of chlorination. To be completed by 12th July 1996.

- (a) construct hard "all weather" access to site;
- (b) provide mains power;
- (c) install chlorination plant;
- (d) construct contact tank to give 30 minutes capacity at peak flow rates;
- (e) install chlorine and turbidity monitors and associated telemetry and controls.

2. If coliforms detected in any sample, follow instructions given in sections 7.7 to 7.11 of "Guidance in Safeguarding the Quality of Public Water Supplies" as appropriate. To be completed as soon as analytical results are made available and not more than 30 hours after sampling.

3. is satisfied that Wessex Water Services Limited has given and is complying with an undertaking to take all such steps as appear to the Secretary of State for the time to be appropriate to secure or facilitate compliance with the requirement of Regulation 3(7) of the Water Supply (Water Quality) Regulations 1989.
