## HIGHWAYS ACT 1980

*The A3 Trunk Road (Woolmer Road Junction Improvement Slip Road) Order 199*

*The A3 Trunk Road (Woolmer Road Junction Improvement Side Roads) Order 199*

The Secretary of State for Transport hereby gives notice that he proposes to make the following Orders—

1. An Order under sections 10 and 41 of the Highways Act 1980 which will provide that a road which he proposes to construct along a route about 325 metres in length to connect the northbound carriageway of the A3 trunk Road with the Longmoor Road (C48) roundabout east of Greatham in the county of Hampshire shall become a trunk road from the date when the Order comes into force.
2. An Order under section 14 of the Highways Act 1980, in relation to the new trunk road mentioned at 1 above, which will:
  - (1) authorise him to—
    - (a) stop up highways, and
    - (b) construct new highways
 all in the vicinity of the new trunk road; and
  - (2) provide for the transfer of each new highway to the Hampshire County Council as highway authority from the date
