Notice of application for consent in pursuance of Schedule 10

Notice is hereby given, in accordance with Schedule 10 of the Water Resources Act 1991, that an application had been made to the Environment Agency, Anglian Region by G's Fresh Salads, Barway, Cambridgeshire, for consent to discharge treated sewage effluent. The application is for a Consent to Discharge up to a maximum of 172 cubic metres per day of treated sewage effluent from G's Fresh Salads Preparation Buildings and Support Buildings, Hainey Farm, Barway, Near Ely, Cambridgeshire, into a tributary of an IDB drain, a tributary of Soham Lode at National Grid Reference TL 5543 7541.

Application is made to discharge from the above premises with peak discharge occurring between July and October.

Hainey Farm is within the East Cambridgeshire District Council and Cambridgeshire County Council areas.

The tributary has no recognised uses. The uses of Soham Lode include a course fishery, spray irrigation, industrial water supply and moderate amenity.
