DEPOSIT TORFAEN LOCAL PLAN

Notice of Eight Week Non-Statutory Extension to the Consultation Period

Notice is hereby given that the statutory 6 week public consultation period for the Deposit Torfaen Local Plan commenced on 17th June 1996, and is due to end on 29th July 1996.

The County Borough Council is aware that the advice note which accompanied the Representation Form may have led potential objectors to believe they could only object to the inclusion of a proposed site if they could identify an alternative site of similar size. Objectors are under no such obligation and in order to encourage the widest possible publicity and comment on the Local Plan the County Borough Council has decided to extend public consultation by a further non-statutory 8 week period ending at 5 p.m., on 23rd September 1996.

Comments on the Local Plan should be submitted in writing, preferably using the Representations Forms provided, to The Director of Development, 4th Floor, County Hall, Crossyeiliog, Cwmbran NP44 2WN, to be received by no later than 5 p.m. on 23rd September 1996.

Objections and representations should specify the matters to which they relate and the grounds on which they are made, and may be accompanied by a request to be notified at a specified address of the withdrawal, adoption, approval or rejection of the proposals.

The County Borough Council has decided that objections made in accordance with this Notice, together with objections which were duly made during the statutory 6 week period, may be heard at the Public Local Inquiry that will be held into the Deposit Torfaen Local Plan.

Copies of the Deposit Local Plan are available for public inspection, free of charge, during normal office hours at the Development Department, 4th Floor, County Hall, Crossyeiliog, Cwmbran, where copies of the Draft Local Plan, may be purchased at a cost of £5 to local residents and £20 in all other cases.

Copies of the Deposit Torfaen Local Plan are also available for public inspection, during normal opening hours, at the Blaenavon, Abersychan, Pontypool and Cwmbran Libraries.
