The A487 Trunk Road (Lay-by, Garn, near Fishguard, Pembrokeshire) (Prohibition of Waiting) Order 199

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to prohibit vehicles from stopping on the sides of the lay-by lying on the northern side of the A487 Fishguard-Bangor Road (hereinafter referred to as "the trunk Road") at Garn in the county of Pembrokeshire in the Schedule to this Order.

A copy of the proposed Order together with a plan and a statement of reasons for the making of the Order, may be seen during normal office hours at the offices of Pembrokeshire County Council, Town Hall, Market Square, Fishguard, for a period of 21 days from 2nd August 1996, and may be obtained, free of charge, from the address below quoting the Welsh Office reference.

Objections, specifying the grounds on which they are made, and quoting Ref. ZC 510-2-27-1 must be sent in writing to the Welsh Office, Highways Directorate, RA3, Cathys Park, Cardiff CFI 3NQ, by 23rd August 1996. In the preparation of an objection and the statement of grounds of objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

SCHEDULE

- 1. The eastern and western sides of the accesss road to the lay-by from the trunk road situated 42 metres east of the centrepoint of the western most access to the lay-by from the trunk road near the properties known as Capel-newydd.
- 2. The northern side of the lay-by which extends from a point 50 metres north-east of the centrepoint of the western most access to the lay-by from the trunk road near the properties known as Capelnewydd in a general easterly direction for a distance of 62 metres.
- 3. The southern side of the lay-by which extends from a point 52 metres north-east of the centrepoint of the western most access to the lay-by from the trunk road near the properties known as Capelnewydd in a general easterly direction to its junction with the main carriageway of the trunk road at the eastern most access to the lay-by near the property known as Bryn Cottage.
