This Order may be cited as the Cattle Passports Order 1996 and shall come into force on 1st July 1996. This Order establishes a system of movement documents for cattle ("cattle passports") for cattle born in Great Britain after the date of coming into force of this Order or imported after that date, and establishes the form of those passports (article 2 and the Schedule). It prohibits the movement of cattle on or off holdings without a cattle passport, subject to exceptions for young calves and imported cattle (articles 3 to 5). It establishes how to apply for a cattle passport (article 6) and sets out when particulars in the passport must be completed (articles 7 to 9).
