The A489 Trunk Road (Penegoes, Powys Council) (40 m.p.h. Speed Limit) Order 199

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under section 84 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to prohibit the driving of motor vehicles at a speed exceeding 40 m.p.h. in the length of the A489 Newtown-Machynlleth Trunk Road (hereinafter referred to as 'the trunk road') specified in the Schedule to this notice.

During a period of 21 days from 31st August 1996, a copy of the proposed Order, relevant plans and the statement of reasons for making the Order, may be inspected during normal office hours at Powys Council, The Park Offices, Newtown, and may be obtained, free of charge, from the address below, quoting the Welsh Office reference.

Objections, specifying the grounds on which they are made and quoting reference ZC 510-6-06-2, must be sent in writing to the Welsh Office, Highways Directorate, Roads Administration Division, Cathays Park, Cardiff CF1 3NQ, by 21st September 1996. In the preparation of an objection and the statement of grounds of objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

SCHEDULE

Length of the trunk road at Penegoes in the county of Powys:

That length of the A489 trunk road at Penegoes in the county of Powys, which extends from a point 200 metres north-east of its junction with the U2274 to a point 40 metres west of its junction with the U2272, a total distance of 525 metres. (482)

The Trunk Roads (A458) and (A483) (Welshpool, Powys) (Prohibition and Restriction of Waiting and Prohibition of Loading and Unloading) Order 1993 (Variation) Order 1996.

Notice is hereby given that on 19th August 1996, the Secretary of State made the above Order, which will come into operation on 2nd September 1996.

The effect is as stated in notice 481 in *The London Gazette* No. 54445, dated 21st June 1996.

Anyone wishing to question the validity of the Order or of any of its provisions on the grounds that it is not within the powers of the relevant section of the Act or that any requirement of that Act or any Instrument made under it has not been complied with, may, within 6 weeks of 30th August 1996, apply to the High Court for this purpose.
