#### *Notice of application for a licence to abstract water*

Take notice that Hallsworth (Farmland Trust) Ltd., of Kelsale Hall Farm, Kelsale, Saxmundham, Suffolk IP17 2QZ, is applying to the Environment Agency for a licence to abstract water from underground strata at National Grid Reference TM4373 6928 at Westleton, Suffolk.

The proposal is to abstract water at the following rates: 50 cubic metres per hour, 1,100 cubic metres per day, 68,200 cubic metres (between March and October) each year. The water will be used for spray irrigation. This is a renewal application for licence numbered 7/35/3/G/70, which expires on the 31st October 1997, with no increase in licence quantity.

Also to vary the licence serial number 7/35/2/G/138, to abstract water from underground strata at National Grid Reference TM443 711 at Westleton, Suffolk.

The variation being applied for is to change the use of 10,000 cubic metres per year, from spray irrigation to stock watering at the rate of 40 cubic metres per day and 4 cubic metres per hour. The total amount will remain unchanged at 76,000 cubic metres per year and 1,500 cubic metres per day.

### SOUTHEND-ON-SEA BOROUGH COUNCIL

#### *The Borough of Southend-on-Sea (Marine Parade) (Experimental Prohibition of Driving) (Variation) Order 1996*

Notice is hereby given that the Southend-on-Sea Borough Council, pursuant to arrangement under section 101 of the Local Government Act 1972, with the Essex County Council, in exercise of the powers conferred made the above Experimental Traffic Order ("The Variation Order") under sections 9, 10 of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act the effect of which is as follows:

To vary The Borough of Southend-on-Sea (Marine Parade) (Experimental Prohibition of Driving) Order 1996 ("the First Order") so that in the Schedule thereto the words "between 06.00 hours on 8th September 1996 and 02.00 hours on 9th September 1996" are substituted for the words "between 16.00 hours on Saturday, 7th September 1996 and 06.00 hours on Sunday, 8th September 1996".

The effect of the Variation Order is that driving will be prohibited on the westbound carriageway of Marine Parade, Southend-on-Sea, between Southchurch Avenue and Pier Hill, between 16.00 hours on Saturday, 7th September 1996 and 06.00 hours on Sunday, 8th September 1996, which supersedes in part of the prohibition of driving as stated in the First Order between 06.00 hours on 8th September 1996 and 02.00 hours on 9th September 1996.

A copy of the First Order and the Variation Order ("the Orders") together with a map showing the roads to which each Order relates may be inspected at the Director of Engineering Services Office, on the 12th floor of the Civic Centre, Victoria Avenue, Southend-on-Sea, between the hours of 9 a.m. and 5 p.m. on Mondays to Fridays (inclusive).

The Orders contain exemptions relating to access for authorised vehicles, emergency services, public service vehicles and traders to premises, taking direct access from the westbound carriageway of Marine Parade (Southchurch Avenue to Pier Hill).

The Variation Order will remain in force until 8th September 1996. The Council will monitor the scheme and consider objections/representations made to it before deciding whether or not to introduce a permanent scheme or carry out further experiments.

## CITY OF LONDON

*City of London (Provision of a Bus Lane in Bishopsgate and in Gracechurch Street)*

Notice is hereby given that the Common Council of the City of London on 30th August 1996, made the City of London (Bus Lane) (No. 1) Order 1996 under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985.

Notice of the Common Council's intention to make the Order was first given in *The London Gazette* on 19th September 1995, page No. 2744, Ref. 568 and the effect of the Order will be the same as given in that notice.

The effect of the Order will be to prohibit any vehicle from entering or proceeding in the area of carriageway (known as the "bus lane") lying within or adjacent to the length of:

- (a) *Bishopsgate*, specified in the Schedule to this notice and between the south-eastern edge of the carriageway and a longitudinal single white line marked on the carriageway broken by the south-eastern edge of the reservation situated within that length of road;
- (b) *Gracechurch Street*, specified in the Schedule to this notice and between the north-western edge of the carriageway and a longitudinal single white line marked on the carriageway broken by the north-western edge of the reservation situated within that length of road.

Exemption has been provided in the Order, in relation to:

- (a) a vehicle being used to provide an authorised bus service;
- (b) a vehicle being used for ambulance, fire brigade or police purposes in an emergency;
- (c) any vehicle being used in connection with the removal of any obstruction in the bus lane;
- (d) a vehicle being used in the service of a local authority for the purpose of cleansing or for the purpose of collecting refuse from premises adjacent to a bus lane, in connection with the improvement or reconstruction of the highway in or adjacent to a bus lane, the laying, erection, alteration or repair in or adjacent to a bus lane of any sewer or of any main, pipes or apparatus for the supply of gas, water or electricity, or of any telecommunication system, or the placing, maintenance or removal of any traffic sign, provided that in all the circumstances it is reasonably necessary for the vehicle to enter a bus lane;
- (e) a Royal Mail liveried vehicle
  - (i) while postal packets addressed to premises adjacent to bus lane are being unloaded from that vehicle or, having been unloaded therefrom, are being delivered; or
  - (ii) while postal packets are being collected for loading on the vehicle from premises or posting boxes adjacent to a bus lane or, having been so collected, are being loaded thereon;
- (f) to any person causing or permitting any vehicle to enter or proceed in a bus lane:
  - (i) if that person is obliged to do so in order to avoid an accident and forthwith causes that vehicle to leave a bus lane;

(d) *Crown Land*: development by the Crown does not require planning permission but special arrangements do operate whereby general proposals by Government Departments are notified to the Local Planning Authority. Publicity will be given to proposals on the same basis as the publicity given to planning applications.
