INTERIM OPEN GENERAL LICENCE

CHEMICAL WEAPONS ACT 1996

This Licence is granted by the Secretary of State, in exercise of the powers conferred by section 20 of the Chemical Weapons Act 1996 (c.6).

Interpretation

Terms and expressions used in this Licence shall bear the same meanings as they have in the Chemical Weapons Act 1996.

Authorisation

This Licence authorises any person to:

- (a) use any Schedule 1 toxic chemical or precursor for a permitted purpose; and
- (b) to produce or have in his possession any Schedule 1 toxic chemical or precursor with the intention that it will be used for a permitted purpose.

Period of Licence

The Licence shall come into force on 16th September 1996, and shall expire at midnight on 31st December 1996.

The definitive licensing regime, under section 20 of the Chemical Weapons Act 1996, will be introduced from 1st January 1997, and will take two forms; an Open General Licence, with reporting requirements, for production, possession and use of up to 5 grammes of Schedule 1 chemicals for research, medical or pharmaceutical purposes, and individual licences covering quantities over 5 grammes. ROAD TRAFFIC REGULATION ACT 1984

The A205 Trunk Road (Hounslow) Red Route (Bus Lanes) Experimental Traffic Order 1996

The Traffic Director for London, following a direction given to him by the Secretary of State for Transport under section 58(1) of the Road Traffic Act 1991, to implement a Trunk Road Local Plan, hereby gives notice that he made the above-named experimental Order under sections 9 and 10 of the Road Traffic Regulation Act 1984, on 5th September 1996. The Order comes into effect on 21st September 1996, and can remain in force for up to 18 months.

The general nature and effect of the Order will be to provide a bus lane on the north-west side of the A205 Chiswick High Road, between a point approximately fifty metres south-west of the Capital Interchange Way junction and a point approximately fifty metres south-west of the Chiswick Roundabout.

The road affected by the Order is the A205 Chiswick High Road, in the London Borough of Hounslow.

While the Order is in force the Traffic Director for London, or some person authorised by him, may modify or suspend the Order or any provisions in it if it appears essential to do so for certain purposes.

In due course the Traffic Director for London will be considering whether or not the provision of the Order should be continued in force indefinitely. Within the period of six months from the coming into force of the Order, or if the Order is subsequently varied by another Order or modified, from the coming into force of that variation or modification (whichever is the latest), any person may object to the making of an Order to continue indefinitely those provisions. ROAD TRAFFIC REGULATION ACT 1984

The A205 Trunk Road (Hounslow) Red Route Traffic Order 1996

The Traffic Director for London, following a direction given to him by the Secretary of State for Transport under section 58(1) of the Road Traffic Act 1991, to implement a Trunk Road Local Plan, hereby gives notice as follows:

The A205 Trunk Road (Hounslow) Red Route Experimental Traffic Order 1995, (the "experimental Order") was made under section 9 of the Road Traffic Regulation Act 1991 and comes into force on 22nd March 1995.

Notice of the making of the experimental Order was published on 3rd February 1995. That notice contained a statement that the Traffic Director would be considering in due course whether the provisions of the experimental Order should be continued in force indefinitely. The Traffic Director has carefully considered whether or not those provisions should be continued indefinitely and has decided that they should be so continued.

Therefore, in exercise of the powers conferred on the Secretary of State by section 6 of the Road Traffic Regulation Act 1984, and in accordance with regulation 14 of the Secretary of State's Traffic Orders (Procedure) (England and Wales) Regulations 1990, the Traffic Director has made the A205 Trunk Road (Hounslow) Red Route Traffic Order 1996 (the "permanent Order"). That Order will come into force on 21st September 1996, and the effect of that Order will be to continue in force indefinitely the provisions of the experimental Order.

The roads affected by the permanent Order, are the A205 Chiswick High Road, Kew Bridge, (North Circular Road) and Kew Road in the London Borough of Hounslow.
