  - 3. The effect of the Prescribed Routes Order will be to prohibit:
  - (a) motor vehicles entering the length of Moorfields which lies between Moor Place and the southern extremity of Moorfields;
  - (b) vehicles (except pedal cycles) from using Fore Street Avenue as a through route. (A barrier will be erected in the carriageway near to its junction with Moorfields.)
- The prohibition referred to in paragraph 3(a) above will not apply to:
  - (a) a vehicle being used for ambulance, fire brigade or police purposes in an emergency; or
  - (b) a vehicle being used for purposes in connection with the statutory powers or duties of a local authority or for the supply of gas, water or electricity, or in actual use in connection with any building operation, demolition or excavation in or adjacent to Moorfields, provided that in all the circumstances it is reasonably necessary for the vehicle to enter that length of Moorfields:
  - (c) any person causing any vehicle to enter that length of Moorfields for the purpose of delivering or collecting goods or loading or unloading a vehicle therein or for the purpose of gaining access to premises accessible only therefrom; or

(d) anything done:

- (i) with the permission or at the direction of a police constable in uniform;
- (ii) in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the City Police.
- 5. The general effect of the Waiting and Loading Restriction Order will be further to amend the City of London (Waiting and Loading Restriction) (Special Parking Area) Order 1994, so that:

- (a) waiting by vehicles for the purpose of delivery or collecting goods or loading or unloading a vehicle will be prohibited between 8.30 a.m. and 6.30 p.m., on Mondays to Fridays, inclusive and between 8.30 a.m. and 1.30 p.m. on Saturdays in the length of street specified in the Schedule to this Notice;
- (b) a motor cycle parking bay in Moorfields will be relocated to Fore Street Avenue.
- 6. The effect of the parking places Orders will be to:
- (a) revoke the designation of metered parking places in Moorfields;
- (b) designate a disabled persons parking place in Fore Street Avenue; and
- (c) designate a parking place for bicycles in Moorfields.
