Notice is hereby given that the Doncaster Borough Council propose to make an Order under the provisions of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to introduce a 40 m.p.h. speed limit on that length of the A614 Selby Road at Thorne which extends from a point 61 metres west of its junction with Brooke Street for a distance of 240 metres in a westerly direction.

## GATESHEAD METROPOLITAN BOROUGH COUNCIL

*The Borough Council of Gateshead (High Lanes, Heworth) (Bus  
Stop Clearway) Order 1996*

Notice is hereby given that on 24th September 1996 the Borough Council of Gateshead made an Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984.

The effect of the Order, which comes into operation on 1st October 1996 is to introduce a bus stop clearway (7 a.m. to 7 p.m. on any day) on High Heworth Lane between the junctions of Heworth Lane and Grange Crescent.

All vehicles other than buses would be prohibited from waiting at those bus stops marked with the clearway markings.

*Hartlepool Borough Council (Colwyn Road/Penrhyn Street)  
(Prohibition of Driving and Waiting) Order 1996*

*Prohibition of Waiting*

(a) *Penrhyn Street*, on both sides of the road from a point approximately 4 metres north of its junction with Colwyn Road and thence in a southerly direction for a total distance of approximately 18 metres including the southern end of the cul-de-sac turning area.

(b) *Colwyn Road*

(i) on the north side of the road from its junction with Penrhyn Street and thence in an easterly direction for approximately 12 metres up to the joint boundary between Nos. 4 and 6 Colwyn Road.

(ii) on the south side of the road from its junction with Penrhyn Street and thence in an easterly direction for approximately 19 metres, to include the vehicular entrance into the Burn Valley Gardens. (514)
