PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975

Notice of the Issue of a Submarine Pipe-Line Works Authorisation

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by Shell U.K. Limited, whose address is Shell Mex House, Strand, London WC2R 0DX, for the short term operation of a 152-4 millimetre pipe-line between Brent Delta and the vessel M.V. Crystal Seas.

Except with the consent of the Secretary of State, the 152.4 millimetre pipe-line shall only be used to convey crude oil/natural gas mix.

The pipe-line may be used by the holder and with the holders' agreement, and with the consent of the Secretary of State, by other persons.

Halliburton Manufacturing and Services Limited has been appointed operator of the pipe-line.
