BILLS RECEIVING ROYAL ASSENT

BURIAL ACT 1853

Notice is hereby given that representations have been made to Her Majesty in Council by the Secretary of State for the Home Department that burials should be discontinued in the following places of burial and that Her Majesty in Council was pleased on 15th October 1996, to order that such representations be taken into consideration by a Committee of the Privy Council on 3rd December 1996.

1. The remainder of the Churchyard of St. Peter and St. Paul, Dagenham, London Borough of Barking and Dagenham, that is to say, that part of the churchyard in which burials were not discontinued (with exceptions) by Order in Council dated 14th August 1878;
2. St. Mary's Churchyard, Farnham Royal, Buckinghamshire;
3. St. Lawrence's Churchyard, Frodsham, Cheshire;
4. St. Luke's Churchyard, Whaley Thorns, Derbyshire;
5. The remainder of the Churchyard of St. Margaret of Antioch, Durham;
6. St. Cuthbert's Churchyard, Shadforth, County Durham;
7. St. Bartholomew's Churchyard, Thornley, Wolsingham, County Durham;
8. The Churchyard of St. Mary the Virgin, Ashwell, Hertfordshire;

11. The remainder of Holy Trinity Churchyard, Louth, Lincolnshire, that is to say, that part of the churchyard in which burials were not discontinued (with exceptions) by Order in Council dated 19th October 1855;

13. The Cemetery of St. Mary the Virgin, Blakesley, Northamptonshire;
14. All Saints' Old Churchyard, Great Addington, Northamptonshire;
15. The extension to St. Hilda's Churchyard, Hinderwell, North Yorkshire;
16. The Churchyard of St. Mary and St. Laurence, Cauldon, Staffordshire;
17. St. Martin's Churchyard, Talke O'Th'Hill, Staffordshire;
