These are civil proceedings which you should attend to explain to the Court why you feel that the goods should not be condemned as forfeit. You may be legally represented at these proceedings if you wish. It will be a matter for the Court to decide whether or not the goods should be condemned and forfeiture confirmed.

If no claim is made, the goods will be deemed to have been duly condemned as forfeit.
