#### **PUBLIC SCHOOLS ACT 1868**

The Governing Body of Rugby School have made revised Statutes in the terms appended hereto and the same is hereby published in The London Gazette as required by the above-named Act.

Any persons or body corporate authorised by the said Act may within two months after the publication hereof petition Her Majesty in Council to withhold Her Approval from the whole or any part of the said Statutes.

Statutes made by the Governing Body of Rugby School under the provisions of the Public Schools Act 1868

#### Statute 1. Interpretation

- 1.1 In these Statutes the following words and phrases shall have the following meanings unless the context otherwise requires:
- 1.1.1 "the Governing Body" shall mean the Governing Body of Rugby School
- 1.1.2 "special resolution" shall mean a resolution passed by a majority of not less than 75 per cent of the Members eligible to attend and vote at a Meeting of the Governing Body of which not less than 28 days written notice specifying that the resolution to be proposed has been given
- 1.1.3 "Member" shall mean a Member of the Governing Body
- whether appointed or co-opted
  1.1.4 "the Head Master" "Deputy Head" "Assistant Master"
  "Second Master" and "Chaplain" in these Statutes shall be
  taken as appropriate to mean those men or women appointed in accordance with the terms of these Statutes who take part in the regular instruction of the School and who are also entrusted with the powers of correction for the maintenance of discipline
- 1.1.5 "the Companies Acts" shall have the meaning specified in
- section 744 of the Companies Act 1985
  1.1.6 "The Trust Income" shall bear the meaning in clause 10.1
  1.1.7 "Trust Income Account" shall bear the meaning in clause
- 10.2 1.1.8 expression "The Income of the School" shall bear the meaning in clause 11.1
- 1.2 In these Statutes except where the context otherwise requires the masculine shall include the feminine and vice versa and the singular the plural and vice versa:

#### Statute 2. Members of the Governing Body

- 2.1 The Governing Body shall consist of the Lord Lieutenant of the County of Warwick for the time being, as an ex officio Member, and the following Members namely:
  - One Member to be appointed by the Hebdomadal Council of the University of Oxford
  - One Member to be appointed by the Council of the Senate of the University of Cambridge
  - One Member to be appointed by the Senate of the University of London
  - One Member to be appointed by the President and Council of the Royal Society
  - One Member to be appointed by the Lord Chancellor for the time being
  - One Member to be appointed by the Head Master and Assistant Masters of the School
