UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

Two Statutes made by the Governing Body of Magdalen College, Oxford, on 30th October 1996, amending Statutes IV and VIII, have been submitted for the approval of Her Majesty in Council, and notice of their having been so submitted, is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923.

The purpose of these Statutes is to remove the requirement as to length of appointment in relation to pension provision for persons other than fellows; and to increase the maximum number of Honorary Fellows to thirty. (5 SI)
