

1. Instituting any civil proceedings in any Court;
2. Continuing any civil proceedings instituted by her in any Court before the making of this Order; and
3. Making any application other than an application for leave as required by section 42 of the said Act in any civil proceedings instituted in any Court by any person unless Bridget Wray obtains the leave of the High Court having satisfied the High Court that the proceedings or application are not an abuse of the process of the Court in question and that there are reasonable grounds for the proceedings or application.

And It Is Ordered that leave to appeal be refused.
