## DEPARTMENT OF TRANSPORT

### TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the stopping-up of a part of the south-western footway of Colville Gardens (west), London W.11.

If the Order is made, the stopping-up will be authorised only in order to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted to Sproson Barrable by the Royal Borough of Kensington and Chelsea on 5th December 1996, under reference DPS/PA/TP/96/1918/K/42/425.
