The prohibitions referred to in paragraph 1 above will not apply in respect of anything done with the permission or at the direction of

a police constable in uniform.

The Order has provided that in pursuance of section 10(2) of the Road Traffic Regulation Act 1984, the Council's Commissioning Director of StreetCare or some person authorised in that behalf by him, may, if it appears to him or that person essential in the interests of the expeditious, convenient and safe movement of traffic or for preserving or improving the amenities of the area through which any road affected by this Order runs, modify or suspend this Order or any provision thereof.

A copy of the Order, which will come into operation on 3rd March 1997, of a map of the relevant area and of the Council's statement of reasons for making the Order can be inspected, during normal office hours, on Mondays to Fridays inclusive, until the expiration of a period of 6 months from that date, at The One Stop Shop, Brent Town Hall, Forty Lane, Wembley, Middlesex HA9 9HX; The One Stop Shop, Brent House, 349-357 High Road, Wembley, Middlesex HA9 6BZ; and The Highways Consultancy, Pyramid House, Fourth Way, Wembley, Middlesex HA9 0LJ.

Any person desiring to question the validity of the Order or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the date on which the Order was made, make

application for the purpose to the High Court.

If the provisions of the Order continue in operation for a period of not less than 6 months, the Council of the London Borough of Brent will consider in due course whether the provisions of the Order should be reproduced and continued in force indefinitely by means of an Order under section 6 of the said Act of 1984. Persons desiring to object to the making of the Order under section 6 of the said Act of 1984 for the purpose of such reproduction and continuation in force, may, within the aforementioned period of 6 months, send a statement in writing of their objection and the grounds thereof to The Director, Highways Consultancy, Pyramid House, Fourth Way, Wembley HA9 0LJ, quoting the reference TO/6/006/BFM.
