### CUSTOMS AND EXCISE

#### NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

To Kompjuterski Alarmi, Pozeska 36, Belgrade 11030, Yugoslavia. Under section 139(6) of the Customs and Excise Management Act 1979, paragraph 1 of Schedule 3 thereto, the Commissioners of Customs and Excise hereby give you notice that certain goods, namely:

4 Cameras, serial numbers VPM 3030 s/n 01906, VPM 3030 s/n 01947, NCD 432 s/n 31115 and NCD 632 s/n 03148

which have been seized as liable to forfeiture by virtue of Articles 3 and 4 of the Serbia and Montenegro (United Nations Sanctions) Order 1992 and section 68 of the Customs and Excise Management Act 1979.

If you claim that the goods are not liable to forfeiture, you must within one month of the date of this notice of seizure give written notice of your claim in accordance with paragraph 3 of Schedule 3 of the Customs and Excise Management Act 1979. If you are outside the United Kingdom, you must specify the name and address of a Solicitor in the United Kingdom who is authorised to accept service of process and to act on your behalf. If you make such a claim within that time, legal proceedings will be taken for the condemnation of the goods.

These are civil proceedings which you should attend to explain to the Court why you feel that the goods should not be condemned as forfeit. You may be legally represented at these proceedings if you wish. It will be a matter for the Court to decide whether or not the goods should be condemned and forfeiture confirmed.

If no such claim is made, the goods will be deemed to have been duly condemned as forfeit.

You may not want to contest the legality of the seizure but still wish to regain possession of the goods. The Commissioners may

exercise their powers under section 152(b) of the Customs and Excise Management Act 1979 to return goods which have been lawfully seized.

An application for the return of the goods should be sent in writing, within one month of the date of this notice to the following address: Export Licensing and Sanction Team, HM Customs and Excise, 1st Floor Central, New King's Beam House, 22 Upper Ground, London, England SE1 9PJ.

You will be advised whether the goods can be returned, and if so the sum required for their release.

*The A55 Trunk Road (St. Asaph, Denbighshire) (Temporary 40 m.p.h. Speed Limit) Order 1997*

Notice is hereby given that the Secretary of State for Wales intends, in not less than 21 days from the date of this notice, to make an Order under section 14 of the Road Traffic Regulation Act 1984.

The Order is required to enable carriageway works to be undertaken on the A55 Chester Bangor Trunk Road (hereinafter referred to as "the trunk road") in connection with the construction of the Waen to Pont Dafydd Improvement Scheme.

The effect of the Order will be temporarily to impose a 40 m.p.h. speed limit in the length of the trunk road at St. Asaph in the county of Denbighshire which extends from the centrepiece of the St. Asaph Interchange roundabout eastwards for a distance of 3,750 metres (including eastbound entry and westbound exit slip roads) to a point 680 metres east of Waen Crossroads overbridge.

These restrictions will operate from 8 a.m. on 3rd March 1997, until the works, which are expected to take 2 years, are complete. The extent of the restrictions will vary as necessary and will be signed accordingly.
